AFFIDAVIT OF PROBABLE CAUSE

I, Ian Aarts, swear that the above-named defendant was arrested on the date and time above, and for the above crime - that the crime occurred in Lane County, Oregon, and the probable cause for the arrest is as follows:

At the above date and time, while working as a Police Officer for the City of Eugene, I arrested Diana Ott after reviewing the attached original probable cause affidavit prepared by Officer B. Harris and continue to believe that probable cause exists for the above listed crimes.

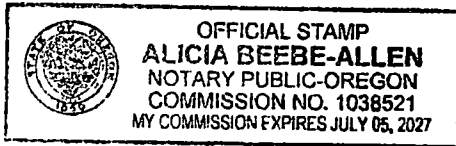
Post Miranda Ott told me she recalled an incident at Coastal in July or August where she trespassed from the location. She described approaching the registers with some items in her cart and an employee told her she was trespassed and if she returned, they would press charges against her.

She recalled a prior incident where she had the wrong label on a pair of boots. When the employee mentioned it to her, she asked the employee to put the boots back and didn't want them anymore.

Ott denied the allegations of swapping tags from cheap items onto more expensive items. She told me other than the aforementioned boots she mostly bought things from the warehouse which required her to bring a tag to the register and then pick the item up from the warehouse after paying for the items. She told me after being trespassed she never returned to Costal and again estimated this to have occurred in July or August.

I asked her if she had a sibling who looked like her. She told me she had a sister who was smaller than her and wasn't so close as to pass for her. She also added her sister had only been to Costal one time that she know of.

She told me about a previous incident when she worked at Walmart where she was arrested for theft 1 for stealing from the register.
