<u>Count 15</u>- subject to ORS 137.717 - 13 months DOC -1 year post-prison supervision (sentence runs concurrently with counts 1,2,4, and 10)

<u>Count 17</u> - subject to ORS 137.717 - 13 months DOC -1 year post-prison supervision (sentence runs concurrently with 1,2,4,10, and 15)

<u>Count 21</u> – subject to ORS 137.717 - 13 months DOC, 1 year post-prison supervision – (7 months to run concurrent with counts 1,2,4,10, 15, and 17 remaining 6 months to run consecutively)

<u>Count 28 –</u> subject 137.717 - 13 months DOC – 1 year post-prison supervision, (sentence to run concurrently with Counts 1,2,4,10,15,17, 21, 26, and 27).

<u>Count 30 – 6</u> months jail to be served concurrently with Counts 1,2,4, 10,15,17,21, 26, 27, and 28.

Count 31 – 6 months jail to be served concurrently with Counts 1,2,4, 10, 15, 17, 21, 26, 27, 28, and 30.

<u>Count 36 – Stipulated upward durational departure to 36 months DOC</u> 2 years post-prison supervision, (18 months to be served concurrently with Counts 1,2,4,10,15,17,21,26,27,28,30, and 31, remaining 6 months to be served consecutively)

<u>Count 37 – Stipulated upward durational departure to 36 months DOC</u> 2 years post-prison supervision (18 months DOC to be served concurrently with Counts 1,2,4,10, 14,17,21, 26,27, 28, 30, 31, and 36, the remaining 18 months to be served consecutively)

Count 41 – subject to ORS 137.717 – 13 months DOC – 1 year post-prison supervision (7 months to run concurrently with Counts 1,2,4,10, 15, 17,21, 26,27,28,30,31,36, and 37 the remaining 6 months to run consecutively)
